First line support	<ul> <li>Resolve any immediately solvable problem.</li> <li>Escalate any other problem to the relevant person within the ICT department.</li> <li>Report any suspected "bugs" to NetSuite support.</li> <li>Report any enhancement requests to NetSuite and keep staff updated as to the progress of their request.</li> <li>Support and maintain equipment (desktops, laptops, printers and other peripherals)</li> </ul>
NetSuite Maintenance	<ul> <li>Run daily, weekly and monthly maintenance.</li> <li>Maintain "public" saved searches and views.</li> <li>Create and modify NetSuite searches and reports.</li> <li>Maintain NetSuite forms to make sure they meet the business needs.</li> <li>Create and modify NetSuite email templates</li> <li>Maintain roles and dashboards for staff</li> </ul>
Documentation	<ul> <li>Document the internal design of any development in order to ease maintenance in the future.</li> <li>Create and maintain user instructions and maintenance guides where appropriate.</li> </ul>
NetSuite Development and Support	<ul> <li>Work with the Systems Analysts to develop bespoke solutions suited to the business needs.</li> <li>Willingness to learn JavaScript, HTML, FreeMarker and basic SQL to support the Systems Analysts in the development of NetSuite.</li> <li>Maintain own tasks within the company project management tools.</li> </ul>
